The minutes for the March 4, 2024, meeting was submitted. A motion was made by Christine Jeffries, seconded by Katie Wood, unanimously approved. One change to the minutes from last month Katie Wood was in attendance.

Washington St Bridge: Doug Krieger gave a brief update on the Washington St bridge construction. Two weeks prior the big part of the cement was poured. The goal is to shift the traffic over to the east side by the end of May. The west side should go a little quicker with a projected finish date in November of this year.

Washington Streetscape: Doug Krieger also gave an update on the streetscape. Construction is moving along with a few surprises such as underground storage tanks outside of Bev's. They are still on track to have everything completed by the end of 2024.

Wayfinding Signs: Doug Krieger updated the committee on the wayfinding sign project for downtown. They are currently in the consultants' hands.

Century Walk: Discussions continue with Century Walk and the City looking at the future. Doug Krieger stated that they are focusing on 2024, the last year of the contract on maintenance. They are putting together a successor organization that would be responsible for the maintenance and new items. They are meeting again on Friday April 12 at 4pm.
